**\*\*\*Change in delivery type for American Journal of Recreation Therapy and American Journal of Disaster Medicine**

The *American Journal of Recreation Therapy* and the *American Journal of Disaster Medicine* have changed to a continuous publication model for 2024. This strategy leverages online capabilities to promptly release articles once they have completed peer review, Editorial Board approval, copyediting, typesetting, and proofreading. Unlike the traditional practice of waiting for a complete journal issue, approved articles are published more quickly, enhancing the service for authors and readers and expediting scientific dissemination.

The journal's website will constantly receive content throughout the year. When enough articles are published to create an issue, we will close the issue and print and mail the physical issue (to print only or print + online subscribers). Consequently, articles no longer have to await issue completion, aligning with the pace of discoveries and enabling authors to share their work promptly.

## Electronic Journal User Agreement

Version 5.1 01/01/2020

The following guidelines provide electronic journal Individual/Corporate/Library Subscribers with a set of simple, commonsense rules governing rights and limitations for internet access of electronic versions of Weston Medical Publishing, LLC (Publisher) electronic journals by Authorized Users. These guidelines supersede any prior understanding between the Publisher and the Individual/Corporate/Library subscriber (Subscriber) regarding user access to electronic journals.

Access to Weston Medical Publishing, LLC electronic journals is granted for all Authorized Users on the following conditions:

- Publisher's acceptance of the Subscriber's completed order
- Receipt of the required subscription fee
- Receipt of list of Corporate/Library Subscriber's IP addresses, if applicable

**Authorized Users:** Individual subscribers are the only authorized user for their subscription. The subscriber is prohibited from making agreements for access to the electronic journals with individuals, organizations, vendors, affiliates, or partners.

Corporate/Library "Authorized Users" are authenticated, authorized current full and part time students, employees (including faculty, staff, affiliated researchers and approved contractors), and other individuals who have permission to use the institution computers on the Subscriber's geographically constrained site.

**IP Access Consolidation:** Corporate/Library subscribers using a single IP address (Proxy Access) to access subscriptions and/or centrally administering their library resources for multiple campus locations (physical sites) are required to notify Weston Medical Publishing, LLC when subscribing to electronic journal content. Such Corporate/Libraries may be required to pay multi-site access fees and/or subscription surcharges based on their number of campus sites and all site FTEs (subscriber base) at each location, not just relevant FTEs. A "site" is an organizational unit, and may be academic or nonacademic. For organizations located in more than one city, each city office is considered a different site. The Publisher holds the copyright for all works published in the electronic journals, as a compilation and as to the individual articles, collectively and individually, unless otherwise expressly noted.
3. All use of the electronic journal content is subject to applicable Copyright law and reproduction of electronic journal content is allowed only as follows:
  - a. Downloading: Downloading, printing, or saving of content for personal, non-commercial use is permissible. Systematic downloading is forbidden.
  - b. Commercial Redistribution: No commercial use (e.g. downloading, posting of a file, or printing to resell or distribute) of any articles is permitted without prior, express written permission or license from the Publisher (<http://www.copyright.com/get-permissions/>).

- c. Interlibrary Loan: ILL is available through Copyright Clearance Center's Get-It-Now service (<http://www.copyright.com/academia/get-it-now>). Because of the easily reproducible nature of electronic publications, Interlibrary Loan of articles or components in any other electronic or digital form is expressly **PROHIBITED**. Interlibrary Loans to reprint services is not allowed and must be referred to Copyright Clearance Center for collection of royalties.
  - d. Assisted Technologies: The Subscriber may transcribe any portion of the electronic journal into Braille script or enlarged type for Authorized Users who are visually impaired.
  - e. Course Packs: Contributors of articles published in the Journal(s) who are faculty members of the Subscriber may use those articles in any course pack they compile without charge. All other articles used in course packs should be referred to Copyright Clearance Center and their Academic Permissions Service (<http://www.copyright.com/get-permissions/>).
4. Subscriber agrees to the following:
  - a. The Subscriber is responsible for creating and maintaining reasonable security measures, and posting policies consistent with the rights and restrictions described in these guidelines to ensure that only Authorized Users can access the electronic journals. The Subscriber is prohibited from making agreements for access to the electronic journals with individuals, organizations, vendors, affiliates, or partners, which are not parts of the same Subscriber purchasing this subscription. The Subscriber affirms that all IP addresses in the range listed for authorization are specifically controlled by the Corporation/Library for workstations under its administrative control and for the use of individuals who meet the Authorized User definition above. The Subscriber is responsible for maintaining the list of IP addresses of all Authorized Users and providing that to the Publisher with subscription order.
  - b. If the Subscriber becomes aware of unauthorized access to the electronic journals, it will notify Publisher immediately and cooperate in locating and attempting to stop the specific individuals who are abusing the service.
